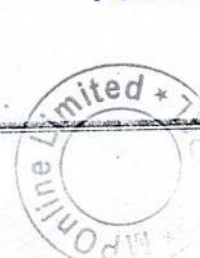

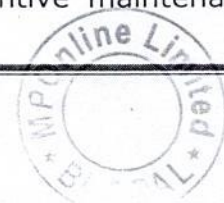

- forthwith by either party if the other shall convene a meeting of its creditors or if a proposal shall be made for a declaration as insolvent or a proposal for any other composition scheme or arrangement (or assignment for the benefit of its creditors), or if a trustee receiver, administrative receiver or similar officer is appointed in respect of all or any part of the business assets of the other party or if an order is made or a resolution is passed for the purpose of the winding-up of the other party or for the making of an administration order (otherwise than for the purpose of amalgamation or reconstruction); by either party pursuant to Force Majeure.


K. DISPUTE RESOLUTION / ARBITRATION

- All disputes, differences, claims and demands arising under the contract shall be referred to the DIT, Government of Madhya Pradesh for their decision and the same shall be binding on all parties, unless either party makes a reference to arbitration proceedings, within sixty days of such decision.
- Department and MPOL shall make every effort to resolve amicably through direct negotiation, any disagreement or dispute arising between them under or in connection with the work order as above. If any dispute arises between parties remained unresolved or is on aspects not covered by this Agreement, or the construction or operation thereof, or the rights, duties or liabilities under these except as to any matter the decision of which is specially provided for by the general conditions, such disputes shall be referred to two arbitrators, one to be appointed by each party and the said arbitrators shall appoint an umpire in writing before entering into the reference and the award of the arbitration or umpire, as the case may be shall be final and binding on both the parties.
- The arbitrators or the umpire, as the case may be, with the consent of the parties, may modify the time frame for making and publishing the award. Such arbitration shall be governed in all respects by the provision of the Arbitration and Conciliation Act, 1996 or later and the rules framed thereunder and any statutory modification or re-enactment thereof. The arbitration proceeding shall be held in Bhopal, Madhya Pradesh.

- Rebellion, revolution, insurrection, mutiny, usurpation of civil or military Government, conspiracy, riot, civil commotion, and terrorist acts; or
- Confiscation, nationalization, mobilization, commandeering or requisition by or under the order of any Government or de jure or de facto authority or ruler, or any other act or failure to act of any local state or National Government authority; or

Memorandum of Understanding | 2017

1. This Agreement is signed on this 20th day of January, 2017 between the Registrar, Pt. 2. The CHIPS agrees to provide the software solution services to Pt. Sundarlal Sharma (Open) University, Chhattisgarh to rollout a centralized comprehensive Student Life Cycle Management System which would include implementation services, maintenance and support up to 24th June of 2024.
3. The CHIPS agrees to provide the following services:
 - i. Assistance in designing, development and maintenance of web based software as a service for Student Life Cycle Management system. The student lifecycle management system will have the following modules – student admission, course management, student batch management, student features relating to tasks and notifications, student access and self-service, pre-exam processing, academics, MIS, fee payment and other financial reports, system administration and configuration set up. As per requirement of Pt. Sundarlal Sharma (Open) University, Chhattisgarh administration Post-exam processing and result, Certificate generation modules of SLCM may be included later.
 - ii. To provide integration services with payment gateways as and when directed by Pt. Sundarlal Sharma (Open) University, Chhattisgarh for smooth collection of examination fee and other payments, if any, for Pt. Sundarlal Sharma (Open) University, Chhattisgarh.

4. Payments :

- i. The students of Pt. Sundarlal Sharma (Open) University, Chhattisgarh will be charged by CHiPS at the rate of INR 50 plus applicable taxes (Service Tax) per year as portal charge. The number of successfully registered candidate in the system would be fixed on the basis of unique registration numbers present in the system. This would be per year basis. The student would be provided with unique user id and password to log into the system.
- ii. CHiPS will raise invoice to Pt. Sundarlal Sharma (Open) University, Chhattisgarh after completion of admission process of that year. The payment will be made within 30 days of submission of the invoice for the session Jan-Dec 2017. For the session Jul-June 2017-18 and onwards, payment will be made on weekly basis during admission process of that respective session.
- iii. CHiPS shall depute One Technical Support Manpower in Pt. Sundarlal Sharma (Open) University, Chhattisgarh, for a period of 3 months from the day of Go-Live on need basis. The number of support manpower can be increased at a later stage, if need arises. Pt. Sundarlal Sharma (Open) University, Chhattisgarh will make payment to CHiPS within one month of submission of the invoice. The deputed technical manpower should be under supervision of Pt. Sundarlal Sharma (Open) University, Chhattisgarh.
- iv. CHiPS shall also deploy Data Entry Operators in Pt. Sundarlal Sharma (Open) University, Chhattisgarh on need basis, with prior approval from Pt. Sundarlal Sharma (Open) University, Chhattisgarh for carrying out data entry work of legacy data for go-live of system. CHiPS will raise invoice to Pt. Sundarlal Sharma (Open) University, Chhattisgarh on quarterly basis. The payment will be made within 30 days after submission of invoice.






