1. Parties

The parties to this MEMORENDUM OF UNDERSTANDING are

- [Govt. Swami Atmanand P.G. College, Narayanpur] hereafter referred to as "[SAPG College]"

2. Purpose

- (e) Joint consultancies.

- (g) Exchange of academic materials and other information.

- (h) Exchange of resources for academic purpose.
- 2.2 A Memorandum of Understanding (MOU's) shall be developed for specific agreements based on the mutually agreed upon objectives and outcomes, at any time, but require the signatures of both Registrar of the university and Principal of the college.
- 2.3 The purpose of this MEMORENDUM OF UNDERSTANDING is to outline an academic and management framework between the two parties, designed to promote internationalization at both institutions. The parties do not intend to be legally bound to each other, and this MEMORENDUM OF UNDERSTANDING does not impose legal obligations on either party.

- 6.2 Each party shall co-indemnify and hold each party harmless for any and all costs or expenses associated with damages or claims arising out of activities commenced under this MEMORENDUM OF UNDERSTANDING, or any act or omission of the party, its employees or others acting on its behalf while undertaking any aspect of these cooperative activities.
