1. Parties

The parties to this MEMORANDUM OF UNDERSTANDING are

- Pandit Sundarlal Sharma (Open) University Chhattisgarh, Bilaspur hereafter referred to as "PSSOU."
- Shaheed Nandkumar Patel Vishwavidyalaya, Raigarh, Chhattisgarh hereafter referred to as "SNPV"

2. Purpose

2.1 The purpose of this MEMORANDUM OF UNDERSTANDING is to promote international agreement, scholarly collaboration, cultural interaction and friendship by supporting educational, professional and cultural activities among faculty and students of the two institutions. Accordingly, the areas of cooperation will include, subject to mutual consent, any programme offered at their institution as felt desirable and feasible on either side and that both sides will contribute to the fostering and development of the cooperative relationship between the two institutions.

Specific areas of cooperation between the two institutions, subject to the availability of funds and the approval of SNPV and PSSOU, include, but not limited to the following:

- (a) Exchange of faculty members;
- (b) Joint research activities;
- (c) Participation in seminars and academic meetings;
- (d) Developing and executing special academic programmes;
- (e) Joint consultancies;
- (f) Organizing joint conferences/seminars/workshops;
- (g) Exchange of academic materials and other information; and

- (h) Exchange of resources for academic purposes.
- 2.2 A Memorandum of Understanding (MOU) shall be developed for specific agreements based on the mutually agreed upon objectives and outcomes, at any time, but require the signatures of both the Vice Chancellors of the universities.
- 2.3 The purpose of this MEMORANDUM OF UNDERSTANDING is to outline an academic and management framework between the two parties, designed to promote internationalization at both institutions. The parties do not intend to be legally bound to each other, and this MEMORANDUM OF UNDERSTANDING does not impose legal obligations on either party.

3. Notices

5.2 Either party may, with sixty days written notice, terminate the MEMORANDUM OF UNDERSTANDING in advance of its normal expiration or request the renegotiation of its conditions.

- 6.1 Any dispute or difference arisen out of this MEMORANDUM OF UNDERSTANDING shall be resolved through amicable settlement.
- 6.2 Each party shall co-indemnify and hold each party harmless for any and all costs or expenses associated with damages or claims arising out of activities commenced under this MEMORANDUM OF UNDERSTANDING, or any act or omission of the party, its employees or others acting on its behalf while undertaking any aspect of these cooperative activities.
- 6.3 This MEMORANDUM OF UNDERSTANDING is in two originals, and both parties shall hold one original copy.
