#### 1. Parties

- (d) Developing and executing special academic programmes; and
- (e) Joint consultancies.
- (f) Organizing joint conferences/seminars/workshops
  - (g) Exchange of academic materials and other information.
  - (h) Exchange of resources for academic purpose.
- 2.2 A Memorandum of Understanding (MOU's) shall be developed for specific agreements based on the mutually agreed upon objectives and



- outcomes, at any time, but require the signatures of both Registrar of the university and Principal of the college.
- 2.3 The purpose of this MEMORENDUM OF UNDERSTANDING is to outline an academic and management framework between the two parties, designed to promote internationalization at both institutions. The parties do not intend to be legally bound to each other, and this MEMORENDUM OF UNDERSTANDING does not impose legal obligations on either party.
